	pt to be interrupted: (5 voices: Griair, A, B)
1 2 3	Ch: It is time for New Business. Is there any New Business?
4	A: Madam/Mr. Chair
5	Ch: Member A
6	A: I move that we buy 3 computers and set up a website.
7	B: Second
8	
9	Ch: It is moved and seconded to buy 3 computers and set up a website.
10	Ch: Member A, as author of the motion, do you wish to speak first?
11	
12	A: Blah, blah, blanky blah blah!
13	
14	Ch: Are you ready for the question?
15	Ch: All in favor indicate by saying, 'Aye'. All opposed say, 'No'.
16	Ch: The 'Ayes' have it, and the motion is adopted.
17	Ch: The treasurer will write a check.
18	Ch: The next item of business is Announcements.
